

## Accessibility Statement for eReserve Plus

eReserve Pty Ltd is committed to ensuring digital accessibility for people with disabilities. We are continually improving the user experience for everyone, and applying the relevant accessibility standards (VPAT, Section 508 Standards, EN 301 549 and WCAG 2.2).

## Conformance status

The <u>Web Content Accessibility Guidelines (WCAG)</u> defines requirements for designers and developers to improve accessibility for people with disabilities. It defines three levels of conformance: Level A, Level AA, and Level AAA. eReserve Plus is conformant with WCAG 2.2 level A and level AA, and partially conformant with WCAG 2.2 level AAA. Partially conformant means that some parts of the content do not fully conform to the accessibility standard.
